Please ensure that any candidates meet the eligibility criteria:

- Must be at least 16 years old
- Must work in a role that also requires a DBS certificate
- Do not already hold a Child Protection/Safeguarding certificate issued by UK Sport, UK Coaching, the LSCB, The FA, the NHS or any other Government organisation such as the School's authority or Social Services, that is acceptable to the ASA/Swim England. Any candidate who has '1 of the above' will not qualify for NASA funding.

If you are unsure about the validity of a certificate already held by a candidate then you should contact the ASA/Swim England - jenni.dearman@swimming.org.

Grant Aid will be paid retrospectively to the Club (not the Candidate). The amounts shown above are maximum amounts dependant on the cost of the course and other funding applied for/received. Total funding should not exceed the cost of the Course.

Please note that only the online UK Coaching renewal course is acceptable to the ASA/Swim England and currently costs £16.99.

Candidates should download and complete their claim form as soon as they have completed the course and received their certificate. This form and a copy of their certificate should be handed to their Club's Training Officer/Secretary. These, along with a correctly completed Club application form (1 per batch) should be sent to the NASA Grants Secretary either by post, by hand or by e-mail as **.pdf** files for processing.
