### LAST CHANCE - Swim England's Fundraising, Sponsorship and Grant Funding Webinar

Fundraising, Sponsorship and Grant Funding can be critical ways for many clubs to keep their heads above water and generate some additional income. It isn't however an easy source of money and will take time and effort to generate funds from these sources. The session will focus on some of the different ways clubs can fundraise, provide tips and advice on gaining sponsorship and how to successfully secure grant funding if your club is looking to run a be-spoke project. The session is particularly aimed at Club Chairs and Treasurers however is open to anyone involved in the financial running of the club. It will be delivered on Zoom and last for 90 minutes. #### Club Constitution update

At the start of the year Swim England released a new Model Constitution for Unincorporated Clubs. In the interests of good governance, we are asking clubs to update to this new model by the date of your SwimMark or Club Affiliation panel in 2023. To ensure we are able to approve your letter before your panel date please aim to submit your constitution a minimum of 3 weeks prior to your SwimMark/Club Affiliation deadline.

The process has changed slightly and going forward we request that clubs submit their constitution to <u>eastmidland@swimming.org</u> for approval **prior** to approval at your club AGM or SGM.

Attached is a short and simple guide to the new process. We have also attached the model constitution and the constitution guidance notes.

The Swim England Legal Team have worked hard to create the model constitution so we do ask that clubs do not alter the model unless absolutely necessary as alterations may complicate judicial processes. Please ensure constitutions are sent a minimum of 3 weeks before you need approval.

#### New coaching course booking process

Following feedback received regarding awareness of Assistant Coach and Coach courses previously sent out in the weekly email and bookings collected by the Region, we have worked with the IoS to make these more visible by being directly available on the IoS website.

The previous collection route was in place to allow our clubs to access the reduced club offer rate and this is something we have retained, however the attached process is essential to receive the club offer rate. Please make members that are looking to attend Assistant Coach and Coach courses aware of this so they do not book at the full rate price.

A number of other Regions are also having courses directly available so some members may find a course outside the Region is more suitable for them, these courses can be booked at club offer rate by following the same process as given in the document. Attached:

Please do get in touch if you are unsure of your deadline date.

Clubs who will be retaining their affiliation and completing Club Affiliation will need to complete the 5 elements by 16<sup>th</sup> January 2023.

We would like to remind clubs who are due to complete SwimMark; both full accreditations and health checks, and Club Affiliation that you must have submitted all the required elements and had them green ticked at the time of the Regional Deadline.

If you miss the Regional deadline and are completing a full SwimMark accreditation:

• You must have completed the 5 Club Affiliation elements to remain a Swim England affiliated club.

If you miss the Regional Deadline and are completing SwimMark Health Check or Club Affiliation:
You will no longer be an affiliated club of Swim England.

Clubs reaccrediting for SwimMark or Club affiliation in January should have received an email from Helen Bickerstaff yesterday (27.10.22). If you need any support please email <u>Helen</u>.

### Club Personnel Record/Report update

The club personnel record and report available on OMS now shows the role a members DBS was carried out as and whether the member is currently signed up to the DBS update service.

We would recommend clubs carry out a review as soon as possible to ensure no members carrying out roles such as coach, teacher (including assistants), team manager and lifeguard all have an adequate DBS check, if any member in these roles have a DBS check as a poolside helper or pool helper they should be re done as appropriate as soon as possible.

# **GENERAL REMINDERS:**

#### Reducing energy costs

The rising cost of living is impacting on everyone, including clubs and groups. Sport England have recently produced some new guidance for community organisations looking to improve their energy efficiency and reduce their running costs. It sets out the steps organisations can take to do this, including:

- 1. Initiating action empowering a person or working group to investigate and make recommendations.
- 2. Installing smart meters for energy usage establishing benchmarks and finding the best tariffs.
- 3. Taking regular readings tracking energy use against programmes of use to identify peaks and troughs.
- Identifying high energy use items drawing up a priority list and highlighting where reductions can generate savings.

#### OMS submission deadline for 2022

The Online Membership System (OMS) will close for membership batches on Wednesday 14<sup>th</sup> December, if you have any new members or changes for your club that need to be added to OMS, you will need to do it before the deadline. After this date, you will be able to view existing members within the club but not add new members.
