NEW - Swim England Safeguarding Refresher CPD

Swim England have launched a new Safeguarding refresher CPD with additional Mental Health and Self-harm module.

It is one of three new safeguarding refresher modules that will be released by Swim England in 2023 and gives an overview of what safeguarding and child protection means and how to apply that in the practical situation of a club activity.

Among other key items covered in the 90-minute course are:

- The latest safeguarding legislation
- How to recognise types, signs and symptoms of abuse
- Mental health and self-harm
- How to react and respond to an individual who has a concern.

In order to complete the new online refresher CPD, all candidates must be 18 years or over and have completed the three hour Swim England Safeguarding CPD within the last three years. Please click here to book on.

NEW - Applications open for Swim England's Coach 2028 Performance Coach Programme

The 14-month programme is open to coaches of each of the aquatic disciplines and is a key learning opportunity on the coach development pathway.

Up to 18 places are available on the initiative, that is aimed at experienced coaches who are looking to transition their athletes onto World Class Programmes.

Throughout the 14 months, coaches will attend six workshops that will include both skills-based learning and technical content.

The successful applicants will also be provided with a bursary that will allow coaches to carry out specific learning opportunities that are linked to their own personal development plan.
