# New Updates

## **Derbyshire County Short Course - 12,18 and 19 of October - seeking officials please!**

If you are available on any of the above dates, please sign up via the link below. You will be fed and watered throughout the day and will be able to claim mileage in accordance with the County policy. Maximum per claim £50 per day for fully qualified officials.

We expect morning sessions 1 and 4 end at around 11:30, afternoon sessions 2 and 5 at around 13:50 and the later sessions 3 and 6 will end around 17:10.

Sessions 7,8,9 on the third day will be determined when we know how many officials we have but the worst case scenario puts the day ending at just after 6pm. If we can run with 10 lanes it should be about an hour earlier.

A reminder that club constitutions should follow the Swim England model templates. Whilst some areas in red ink can be edited (i.e. the number of committee members), the main contents of the constitution in black ink cannot be altered or removed.

If you are updating your club constitution then it needs to be sent to [eastmidland@swimming.org](mailto:eastmidland@swimming.org) for regional approval prior to adoption at your AGM or SGM. To allow for staff holidays and work capacity, and so that it can be sent to your members prior to your AGM, please send any constitutions to the region a minimum of 3-4 weeks before your AGM.

If you are not changing your constitution then it does not need to be "re-approved" by the region, or adopted again at your AGM.

A reminder to all clubs that the Swim England Safeguarding refresher course should only be undertaken if you have completed the full Swim England Safeguarding Training course within the last 3 years. If you complete the refresher course without having completed the full training course then unfortunately that safeguarding training is invalid.

### **DBS and Safeguarding**

A reminder to all clubs: please ensure you are checking your personnel reports on a monthly basis for any expired, missing or soon to expire DBS checks or safeguarding requirements.

For any role requiring DBS or Safeguarding, these must be in place prior to the role being undertaken.

### **DBS**

DBS checks can be re-applied for prior to expiry so the Swim England DBS team recommend you begin the application process a month before expiry. Please note that the DBS check required for a poolside helper role is at a lower level (without barred list check) than that required for all other roles so if a member has gone from a poolside helper role, into the role of team manager, coach, teacher etc. they will require a new DBS check.

### **Safeguarding**

As of January 2024 the only accepted safeguarding courses are the Swim England safeguarding course, and Swim England safeguarding refresher. The Swim England safeguarding course must be completed first, and 3 years later the refresher can be completed. This is a 6 year cycle so once the refresher expires the full course must be undertaken again.

We have had a number of incidences lately where clubs have been denied an international permit as their coach or team manager has only completed the refresher course, not the full course.

### AGMs

A reminder to all clubs that AGMs should be run in line with your club constitution. Please ensure you check your constitution for all deadlines; i.e. what information should be sent out by which date. Please also ensure you are appointing the correct number of committee members, as stated in your constitution.

For an AGM template please [click here](#).

Points to note:

- You must elect an independent financial examiner each year at your AGM
- Your AGM must include a report from the Chairperson
- Your AGM must include "the accounts of the Club for the previous year and the report on the accounts of the independent examiner and the Treasurer's report as to the financial position of the Club"
- Only paid up members who have reached their 16th birthday shall be entitled to be heard and to vote.

### Course booking reminder - 4 ways to save money!:

1. Ensure you use the [club offer booking process](#) - this heavily discounts the price:

Level 1 Coaching course reduced from £375 to £221.25 (41% discount)

Level 2 Coaching course reduced from £660 to £455.40 (31% discount)

2. If you are a SwimMark club then each year (in line with your reaccreditation date) you will have a £100 IoS voucher which can be used for courses or CPDs.

3. After the member has completed the course and received their certificate, the club can claim a [regional bursary](#) (criteria dependent) of £50 towards assistant coach courses, or £100 towards coach.

4. After the course is completed and certificated, look into the [county bursary funding](#) available.
